### **Sales Tax Exemption**

To claim and receive tax payment exemption from the below states, you must provide *with your order form* a copy of the tax exemption certificate issued by the state Board of Equalization or other authorized issuing agency.

### **California Sales Tax Chart**

Purchasers of taxable items within the State of California are required to pay a sales/use tax on all taxable items purchased. Please pay according to your local (and/or district), county and state tax rate for the locality to which purchases are being shipped.
