GOOD GOVERNANCE PROJECT IS STARTING IN PORTUGAL

The Council of Europe's European Stakeholder Platform for the Strategy on Innovation and Good Governance at Local Level has agreed to accredit UDITE to implement the European Label of Governance Excellence (ELoGE) in Portugal up until 30th June 2022. It will involve the focus shifting to Portuguese municipalities. A call to participate in the self-assessment exercise that could eventually lead to the ELoGE (European Label of Governance Excellence) award will be launched in late 2020 by UDITE and ATAM who will lead this project. WHAT IS THE EUROPEAN GREEN DEAL?

Europe needs a new growth strategy that transforms the Union into a modern, resource-efficient and competitive economy where there are no net emissions of greenhouse gases by 2050, economic growth is decoupled from resource use and no person and no place is left behind. To achieve this ambition, the Green Deal road map will make this happen by turning climate and environmental challenges into opportunities across all policy areas and making the transition just and inclusive for all. Actions are set out that will boost the efficient use of resources by moving to a clean, circular economy restore biodiversity and cut pollution. It outlines investments needed and financing tools available, and explains how to ensure a just and inclusive transition and builds upon the European Covenant of Mayors, with close to 10,000 signatory cities to date, to make it a central force in the fight against climate change..
