Class Descriptions, Presenters and Points*

Municipal Law	Instructor: Phil Warren	1 CMC/MMC point
----------------------	-------------------------	-----------------

This course outlines the various aspects of Municipal Law and its effects on municipal government and its employees. An overview is provided on labor law, general principles of public sector bargaining, Federal Statutes affecting labor relations, the Age Discrimination in Employment Act of 1967, Americans with Disabilities Act of 1990, Fair Labor Standards Act (FLSA), Family and Medical Leave Act of 1993 and Occupational Safety and Health Act of 1970. It provides an understanding of laws used in disciplining an employee, the rights of an employee and the need to increase your knowledge in these areas for yourself and the community.

Municipal Clerks Connection	Facilitator: Kathy Montejo	.5 CMC/MMC point

Join us for an evening session where seasoned and new clerks exchange practical strategies to address challenges that persist even for the most experienced professionals. This session will provide a collaborative space to explore innovative solutions, exchange best practices among the seven states, and tackle common obstacles in municipal operations. The goal is to discuss issues and leave with tangible and actionable solutions equipped with fresh perspectives and effective tools to enhance your approach, ensuring success in your critical role moving forward to assist both your office and your community. This is an opportunity for comradery, idea sharing, professional networking where newer members connect with veteran members, an informal mentoring session, and perhaps some commiserating to know that we are all in this industry called “public service” together.

This course serves to enhance the town clerk's communication skills with the media for the purpose of informing the public of municipal policies, practices, and activities in a positive, consistent and credible manner.

Lewiston Shooting, A Case Study	Instructor: Kathy Montejo	5. CMC/MMC point

What lessons did the city learn from being the site of the country's worst mass shooting in 2023? This class will review what happened from the perspective of non-public safety city employees, what happened within city hall and the community in the 72 hours after the incident, and will review real-world applications to continue with the lessons from Media Relations and Crisis Communication sessions.

Signing Their Lives Away: The Fame and Misfortune of the Men Who Signed the Declaration of Independence

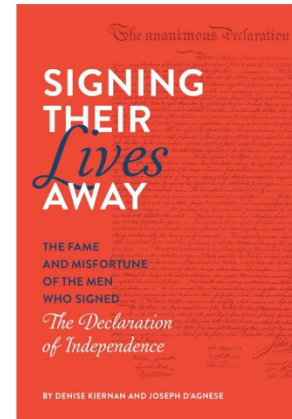
An entertaining and essential collection of stories about the surprising and strange fates of the fifty-six Founding Fathers who signed the Declaration of Independence.
