Each CPMC session earns 30 CMC, MMC, or EPP hours from IIMC. There is also an option to receive 3 university units which can be used to attain the CPMC certificate from UCR. If you already attained the CPMC certificate and/or CMC, you may continue to earn MMC or EPP hours from IIMC.

Information regarding registration and payment for optional UCR certificate units is provided upon completion of CPMC class enrollment. Each CPMC session is eligible for 3 university units at a fee of \$150 payable directly to Regents UC. University unit registration is optional. Registration link and information are sent separately after enrollment in the CPMC session is confirmed.

All participants receive IIMC educational hours upon completion of the session.

Technical Training for Clerks courses were offered from 2002 to 2024 and approved by UCR for units and IIMC for educational hours. TTC classes may be used in conjunction with CPMC sessions to receive a CPMC certificate with one exception. UCR policy dictates you may not duplicate CPMC and TTC numbered sessions for the certificate. You may only use TTC Series 200 or CPMC 200 and TTC Series 300 or CPMC 300 toward the certificate. This UCR policy does not restrict graduation or IIMC hours.

**Upon completion of any four sessions, participants are eligible to “graduate” from CPMC. Registration for UCR units is not required for CPMC graduation.**
