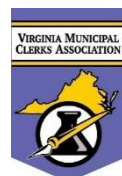

## January IIMC Board Meeting Recap Rancho Cucamonga, California

### RECAP OF IIMC BOARD MEETING

The IIMC Board of Directors met in Ontario, California in January 27 & 28 as a replacement for our Midyear Board meeting that was scheduled for Orlando, FL in November of 2022. Couple of items of importance to you as members that the Board discussed and approved were as follows:

Region VIII – West Director Ida Fierro, New Mexico, was sworn in.  
Reviewed the evaluation of the Executive Director  
Reviewed IIMC's Code of Ethics which will be finalized in May.  
Extended the 2023 Conference Grant Scholarship to February 28, 2023.

Reviewed and approved the following policies:

- a. Elections and Campaigning
- b. Budget and Planning Committee selection of incoming member
- c. This committee as created in summer 2022 and continues to investigate terminology and detail specifics for contract negotiations with Executive Director
- d. Annual Conference updates for 2023, 2024, 2025 and 2026.

Directed the Executive Director to acquire a new attorney experienced in (non-profit) personnel matters and affiliate via a Letter of Engagement – Due May 2023.

Region X – revisit membership dues with option to make it more viable for Canadian members to join IIMC – Due May 2023  
Renamed Athenian Fellows to the Paul Craig Athenian Fellowship

Briefly discussed Study Abroad should be out before the month end registration looking to be around \$3,000 (hotel, meals, etc.). Doesn't include flight.

### Constitutional Proposed Amendments

At the IIMC Board of Directors Mid-Year meeting, the Board voted to make several amendments to the IIMC Constitution. Many of the amendments were merely clerical in nature. The proposed amendments will be presented to attendees at the Annual Business meeting in Minneapolis, MN if approved, changes will be submitted to members 45 days after the conclusion of the annual business meeting

#### ARTICLE IX Board of Director Meetings

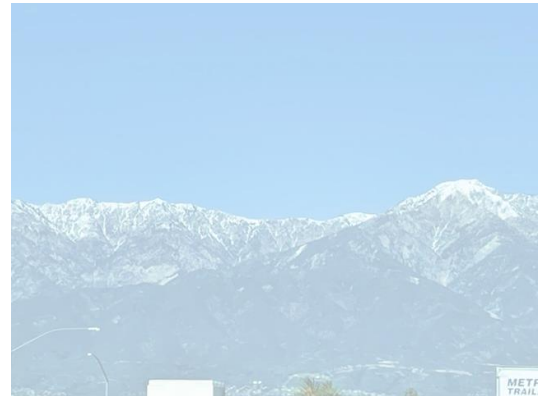
##### Section 4. Attendance at Board Meetings

Board members are required to attend all Board of Directors meetings. A Board member may be excused from two regular meetings during a three-year term. ~~for a valid reason.~~ The request to be excused must be in writing, approved by the President. The Board of Directors will excuse the absence of the President. A third absence is considered a resignation from the position unless there are mitigating circumstances as determined by the Board such as the death of a family member and/or medical problems such as surgery.

#### ARTICLE XV Amendments to the Constitution

##### Section 3. Membership Vote

If the proposed amendment is approved by majority vote at the Annual Business Meeting, the proposed amendment will be distributed for a vote by the entire membership. Members will have forty-five (45) ~~sixty (60)~~ days following the Annual Business Meeting to vote on the proposed amendment.

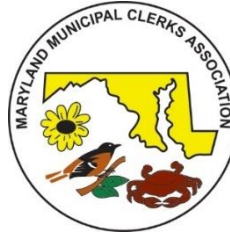

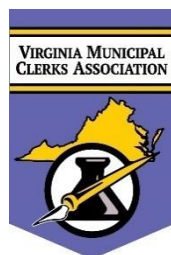

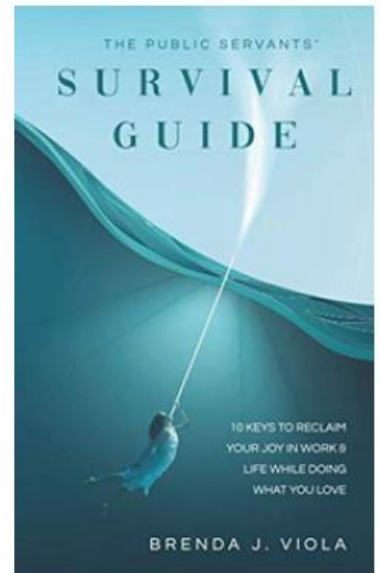

# Athenian Leadership Society

### What Is An Athenian Dialogue?

Dialogues are conversations in which clerks share their experience and understanding as it relates to the ideas of the author and the relevance of those ideas to their public leadership role.

The premise of the Athenian Dialogue Society is the idea that clerks are leaders in very profound yet subtle ways. Leadership here is not the transactional vending machine citizens seem to believe about public management.

Clerk leadership is more transformational in nature. That is to say, the contribution of clerks to municipal leadership changes the perception of colleagues and citizens about the role and purpose of government.

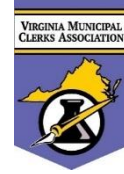

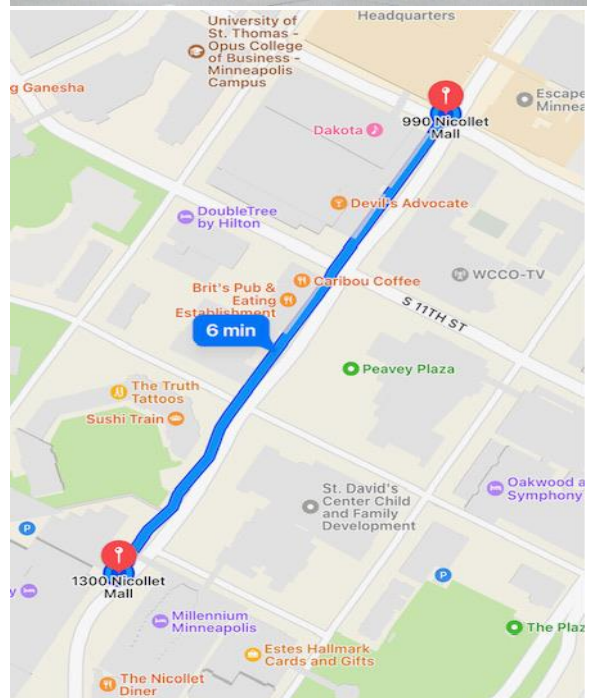
